## ORDINANCE # 1.1

Title: PRIVATE ROAD ACQUISITION

Adopted: 03/24/2015

This is ordinance supersedes ordinance # 3-12-92-b entitled "PRIVATE ROAD ACQUISITION" with a change in numbering, format and wording but no change in substance.

### PRIVATE ROAD ACQUISITION

WHEREAS THE BROOKLYN TOWN BOARD, HAVING BEEN MADE AWARE OF PRIVATE USE ROADS CONSTRUCTED WITHIN THE BOUNDARIES OF THE TOWN OF BROOKLYN AND THESE ROADS LAID OUT AND CONSTRUCTED BY PRIVATE CONTRACTORS TO PROVIDE PROPERTY OWNERS OF OTHERWISE LAND LOCKED PROPERTY ACCESS TO PUBLIC TOWNSHIP ROADS. AND:

WHEREAS THE PROPERTY OWNERS OF THE PRIVATE USED ROAD MAY PETITION THE TOWN BOARD UNDER s.80.02 TO TAKEOVER SUCH ROAD AND MAINTAIN IT AS A PUBLIC ACCESS ROAD. AND:

WHEREAS THE TOWN BOARD, AFTER RESEARCH, HAS DETERMINED THAT THE COST TO THE TAXPAYERS OF THE TOWN OF BROOKLYN, FOR THE ACQUISITION M INTENANCE, AND OR RECONSTRUCTION OF SUCH ROADS, WOULD BE BURDENSOME. NOW:

THEREFORE BE IT ORDAINED, BY THE TOWN BOARD OF SUPERVISORS, In Legal SESSION; THAT IT WILL NOT ACCEPT ACQUISITION OF ANY PRIVATE ROAD UNLESS OR UNTIL THE ROAD HAS MET STATE OF WISCONSIN CONSTRUCTION STANDARDS, AND SHALL BE CONSTRUCTED NO LESS THAN FOUR(4) RODS IN WIDTH WITH STANDARD SHOULDERS, AS PROVIDED IN s.86.26, RIGHT OF WAY, ROADWAY & SURFACE WIDTH, & GRADE WITH A BITUMINOUS SURFACE 2" IN DEPTH.WITH DRIVEWAY PERMIT .
