

# TOWN OF BROOKLYN, GREEN COUNTY, WI

## ORDINANCE #1.4

Adopted: 05/12/2014

Amended: 07/10/2023, adopted 08/14/2023

This ordinance supersedes ordinance # 2012-1017 entitled "Speed Reduction Ordinance" with a change in format, numbering and wording but no change in substance. The ordinance was amended in 2023 to add one additional road.

### Title: Speed Reduction Ordinance

**Section 1 Authority and responsibility** The Town Board has specific statutory authority, powers and duties pursuant to WI Statute 349.11 and duly adopted (1992) village powers under WI Statute 60.22(3) granting to the Town Board powers to regulate, control, license, prevent or permit certain uses and activities for the good order of the Town and for the health, safety and welfare of the public.

**Section 2 Purpose and scope** The purpose of this ordinance is to create a safer travel environment by reducing the speed limit from 55MPH to 45MPH on the following roads:

- a.** A portion of Yarwood Road.
- b.** Glenway Road, from State Highway 92 to Alpine Road

**Section 3 General provisions** This ordinance was adopted on a roll call vote by a majority of the Town Board with a quorum present and voting and proper notice having been given.



## Section 4 Specific Provisions

**4.1 Speed reduction** On the effective date and thereafter, the speed limited is reduced from 55MPH to 45MPH on the following roads:

- a. Yarwood Road, from County Highway E to 1,840 feet west of Benson Road.
- b. Glenway Road, from State Highway 92 north to Alpine Road.

**4.2 Signage** Pursuant to WI Statute 349.11(5), the Town Chairperson or designee shall place appropriate traffic signs at the above-described locations

**4.3 Penalties** Any violation shall be subject to penalties under WI Statute 346.60.

## Section 5 Standard provisions


**5.1 Severability** Provisions of this ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the applicability thereof to any person or circumstance is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

**5.2 Headings and Titles** Headings and labels in this ordinance are for the convenience of the reader only and do not provide independent meaning or substance to this ordinance.

## Section 6 Miscellaneous provisions

6.1 Pursuant to WI Statute 60.80 the clerk shall post this ordinance as required.

6.2 This ordinance is effective upon posting.


